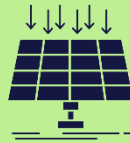

## 1 INTRODUCTION

Tamil Nadu Agricultural University (TNAU) is rated as one of the best Agricultural Universities in India by the Indian Council of Agricultural Research, New Delhi. TNAU is an institute par excellence for higher education in Agricultural and allied subjects. TNAU celebrated its Golden Jubilee during the year 2021.

The vision of TNAU is to promote science-based agriculture and allied processes in the State of Tamil Nadu to help the farmers and agri-based industries to compete successfully in the national and international markets through its education, research and outreach programs.

TNAU originated as an Agricultural School at Saidapet, Chennai, in 1876 and blossomed as a College in Coimbatore in 1906. In 1920, the college was affiliated with the University of Madras with the introduction of a three-year degree program. Till 1946, the Agricultural College and Research Institute, Coimbatore, was the only institute which offered agricultural education for the whole of South India. In 1958, it was recognized as a Postgraduate Centre for offering Masters' and Doctoral degrees. The Agricultural College and Research Institute, Madurai, was established in 1965. These two colleges formed the nucleus of the Tamil Nadu Agricultural University when it was established in 1971 to offer a four-year B.Sc. (Agriculture) degree program.

In the year 1972, two more programs, *i.e.*, B.Sc. (Horticulture) and B.E. (Agriculture), were started. In 1979, the faculty of Horticulture was established. In order to nurture the home-grown innovations, B.Sc. (Home Science) was started at the Madurai campus in 1980. This degree was later renamed as B.Sc. (Food, Nutrition and Dietetics) from 2017 based on the recommendation of ICAR. The third Agricultural College was started at Killikulam in 1984, and the fourth at Navalur Kuttappattu, Tiruchirappalli in 1989. An exclusive B.Sc. (Forestry) program was started in 1985 at the Coimbatore campus and later relocated to Forest College and Research Institute, Mettupalayam in 1991. Later, the B.Sc. (Horticulture) program was shifted to Periyakulam (1990), and B.E. (Agriculture) was shifted to Agricultural Engineering College and Research Institute, Kumulur (1992). The B.E. (Agriculture) program was renamed B.Tech. (Agricultural Engineering) in 2002. A new Horticultural College and Research Institute for Women was established in 2011 at Navalur Kuttappattu, Tiruchirappalli, offering B.Sc. (Horticulture). A unique program, B.Sc. (Sericulture), was started in 2011 at the Agricultural College and Research Institute, Coimbatore and is now offered at Forest College and Research Institute, Mettupalayam.

In the backdrop of changing agricultural situation and developments in science and technology, TNAU introduced unique technology programs *viz.*, B.Tech. (Food Process Engineering) during 1998, B.Tech. (Biotechnology) during 2002, B.Tech. (Energy and Environmental Engineering) during 2004, B. Tech. (Bioinformatics) during 2006, B.Sc. (Agribusiness Management) and B. Tech. (Agricultural Information Technology) in 2007.

Three more constituent agricultural colleges, *viz.*, Agricultural College and Research Institute, Eachangkottai, Thanjavur, Agricultural College & Research Institute, Vazhavachanur, Tiruvannamalai and Agricultural College & Research Institute, Kudumiyamalai, Pudukkottai, were started during 2014. In addition to this, B.Tech. (Agricultural Engineering) has been offered by the Agricultural Engineering College & Research Institute, Coimbatore, since 2019 in a self-supporting mode.

From the academic year 2021-2022, two programs, B.Sc. (Hons.) Agriculture (Tamil Medium) and B.Sc. (Hons.) Horticulture (Tamil Medium) were introduced at AC & RI, Coimbatore, and HC & RI, Coimbatore, respectively. One Horticultural College,

HC & RI, Paiyur, Krishnagiri District, offering B.Sc. (Hons.) Horticulture and three Agricultural Colleges viz., AC & RI, Karur in Karur District, AC & RI, Keezhvelur in Nagapattinam District, and AC & RI, Chettinad in Sivagangai District offering B.Sc. (Hons.) Agriculture started in 2021. The details of constituent colleges and programs offered are appended in Tables 1 and 2, respectively. In addition, 28 private colleges are affiliated with TNAU and offering B.Sc. (Hons.) Agriculture, B.Sc. (Hons.) Horticulture and B.Sc. (Hons.) Agri-Business Management programs (Table 3).

### 1.1.1 Non – Minority Institutions

Sixty-five per cent of total seats in the affiliated colleges are filled by TNAU in general counselling. Please refer to Section 2.1.9 for the nativity requirement for these seats.

Thirty-five per cent of the total seats in the affiliated colleges are filled by the respective management. However, *the candidate must have applied through the TNAU online admission procedure*. The nativity requirement (Section 2.1.9) does not apply to the management quota.

### 1.1.2 Minority Institutions\*

Fifty percent of the seats are filled by TNAU through general counselling and fifty percent by the respective management. The minority institutions must fill their management seats as per the Government norms.

*\* The Status of minority institutions is subject to Government approval.*

### 1.1.3 General instructions for admission under management quota

An affiliated college must adopt all guidelines issued by the Government in its affiliation order. TNAU shall not be held responsible for the deviations committed/done by an affiliated institution in the adoption of prescribed Government guidelines.

The responsibility of verifying the candidate's eligibility for admission to the management seats solely rests with the respective affiliated colleges. TNAU is not liable for answering legal queries for discrepancies or deviations, if any. However, the original certificates of the candidates admitted in the management quota of affiliated colleges will be verified by TNAU at a specified date as deemed fit. If a candidate does not satisfy the eligibility criteria as mentioned in Section 2.1, his / her candidature will not be considered even at a later stage. All seats filled in the management quota are subject to the approval of TNAU.

## 2 ADMISSION DETAILS

### 2.1 ELIGIBILITY FOR ADMISSION TO ALL UNDERGRADUATE PROGRAMS

#### 2.1.1 Educational Qualifications – Academic Stream

Candidates should have passed ALL the subjects in Academic stream of the Qualifying Examination with 10+2 years of schooling under Board of Higher Secondary Education of Government of Tamil Nadu / Central Board of Secondary Education / Council for the Indian School Certificate Examinations / other State Government Boards / other International Boards that are recognized as eligible (based on the subject eligibility) for the following degree programs:

### 2.1.2 Ranking Procedure

The calculation of aggregate is based on the marks obtained by the candidate and not the grades. The candidate must upload the mark sheet (in percentage) given by the appropriate authority. The “additional subjects” shall not be considered for eligibility and ranking.

Grace marks awarded will not be counted for calculating aggregate marks and ranking.

$$\text{Aggregate mark} = \sum \frac{\text{Marks obtained in each subject}}{\text{Maximum Mark for that subject}} \times 50$$

Example:

If a candidate has studied Mathematics, Physics, Chemistry, and Biology and obtained the marks as follows, the aggregate mark (Table 6) shall be calculated as:

If the qualifying examination is other than Tamil Nadu Higher Secondary (HSC) Examination, normalization procedure as ordered in the Tamil Nadu Admission in Professional Educational Institutions Act, 2006 (Tamil Nadu Act 3 of 2007), G.O.M.S.190, Agriculture (AP.6) Department dt. 16.5.2007 and G.O.M.S.191 Agriculture, AP.6) Department dt. 16.5.2007 shall be adopted for computing minimum eligibility and ranking.

### 2.1.3 Determination of the *inter se merit*

In cases where more than one student has got the same aggregate marks in the general rank list, the *inter se merit* among such students shall be determined in the order of priority as specified below (G.O. (Ms.) No.191 (AP.6) Department dated 16.05.2007):

1. **Marks out of 50 in Mathematics. If a student has not studied Mathematics, marks out of 50 in Biology or (Botany + Zoology)**
2. **Marks out of 50 in Physics**
3. **Marks out of 50 in Chemistry**
4. **Date of Birth – Eldest first**
5. **Random Number**

### 2.1.4 Higher Secondary Course (HSC) – Vocational Stream

Five percent of the seats in B.Sc. (Hons.) Agriculture (English & Tamil medium), B.Sc. (Hons.) Horticulture (English & Tamil medium), B.Sc. (Hons.) Forestry and B.Tech. (Agricultural Engineering) at AEC&RI, Kumulur programs in Constituent colleges and B.Sc. (Hons.) Agriculture (English medium) & B.Sc. (Hons.) Horticulture (English medium) in affiliated colleges of TNAU are exclusively reserved for candidates who have qualified under Tamil Nadu Vocational Stream. Therefore, they shall not be considered under the general quota and any other special reservation categories. In this category, both vertical and horizontal reservation policies will be adopted. The students who have studied the following Vocational group during their XII standard are only eligible for the degree programs indicated below:

- I. Candidates who passed Higher Secondary Course (HSC) under Vocational stream and studied Biology and Agricultural Practices as vocational subjects including theory and practical are eligible to apply for the degrees, *viz.*, B.Sc. (Hons.) Agriculture, B.Sc. (Hons.) Horticulture, B.Sc. (Hons.) Forestry and B.Tech. (Agricultural Engineering).
- II. Candidates who passed Higher Secondary Course (HSC) under Vocational stream and studied Biology, Agricultural Science – Theory, Agricultural Science – Practical and Computer Technology as vocational subjects are eligible to apply for the degrees, *viz.*, B.Sc. (Hons.) Agriculture, B.Sc. (Hons.) Horticulture, B.Sc. (Hons.) Forestry and B.Tech. (Agricultural Engineering).
- III. Candidates who passed Higher Secondary Course (HSC) under Vocational stream and studied Biology, Agricultural Science – Theory, Agricultural Science – Practical and Employability Skills as vocational subjects are eligible to apply for the degrees, *viz.*, B.Sc. (Hons.) Agriculture, B.Sc. (Hons.) Horticulture, B.Sc. (Hons.) Forestry and B.Tech. (Agricultural Engineering).

The aggregate calculation pattern followed for academic stream applicants shall also be adopted for the vocational stream studied students. The marks obtained in all four eligible subjects will be converted to 50 marks each, and the aggregate mark will be arrived at.

In cases where more than one student has got the same aggregate marks in the vocational rank list, the *inter se* merit among such students shall be determined in the order of priority as follows:

1. Marks in Biology
2. Marks In Theory Subject
3. Marks in Practical Subject
4. Marks in Fourth subject
5. Date of Birth (Eldest First) &
6. Random Number

**Candidates who have passed Higher Secondary Course (HSC) under Vocational stream from other boards / other states are NOT ELIGIBLE for admission in Tamil Nadu Agricultural University.**

### 2.1.5 Eligible Minimum Qualifying Marks (Academic Stream / Vocational Stream)

The following table (Table 8) lists the eligibility requirements concerning minimum qualifying marks for both academic and vocational stream students.

### 2.1.6 Re-evaluation/re-totaling

The applicants must communicate their details of the reevaluation/retotaling marks to the Chairman (Admissions) through the email [ugadmissions@tnau.ac.in](mailto:ugadmissions@tnau.ac.in) before the counselling, if the reevaluation marks are notified after the publication of the rank lists. Claims at a later date will not be considered for higher-order mark revision. In case of a lower mark revision from the original marks, the admission will be cancelled if acquired with the original marks, and a new allotment will be made as deemed fit if the applicant desires.

### 2.1.7 Number of Attempts to Pass

The maximum number of permissible attempts to pass the qualifying examination is as follows:

- Scheduled Castes / Scheduled Castes-Arunthathiyars / Scheduled Tribes: Three
- All other Communities: Two

### 2.1.8 Age Limit

Candidates should not have completed the age of 21 years on the first day of July of the admission year (*i.e.* as of 01.07.2026). However, there is NO AGE LIMIT for Scheduled Castes (SC), Scheduled Caste-Arunthathiyars (SCA), and Scheduled Tribes (ST). Five years of age relaxation will be given to the differently abled candidates.

### 2.1.9 Nativity

Candidates of Tamil Nadu Nativity only will be considered for general counselling. However, candidates who have studied 10<sup>th</sup>, 11<sup>th</sup> & 12<sup>th</sup> Standards in Tamil Nadu will be considered under open category for admission upon submission of a valid proof issued by a competent authority.

Tamil Nadu candidates who have not studied 10<sup>th</sup>, 11<sup>th</sup> & 12<sup>th</sup> standards in Tamil Nadu should produce the Certificate of Permanent Residence in Tamil Nadu in the prescribed proforma (Appendix-VI) issued by the competent authorities. Candidates possessing a community certificate issued by the Government of Tamil Nadu need not submit Appendix-VI.

### 2.1.10 Physical Fitness

A certificate regarding the physical standards prescribed shall be obtained from the Government Medical Officer and produced at the time of admission.

### 2.1.11 Discontinuing from Tamil Nadu Agricultural University (TNAU)

A student of Tamil Nadu Agricultural University who discontinues an undergraduate degree program at any stage of study after registering for the first semester is not eligible for admission again to any undergraduate programs of this University. Further, if any government quota admitted student (including ICAR) discontinues after 105 working days of first-year first-semester examinations, he/she must pay a DISCONTINUATION FEE of Rupees TWO LAKHS (Rupees 2,00,000/- Only) to TNAU. This condition applies to all the students of constituent colleges and the students who joined affiliated colleges through the TNAU counselling quota. This condition does not apply to the students admitted under the Management Quota in Affiliated colleges.

## 2.2 RESERVATIONS

### 2.2.1 Category-Wise Reservation

The reservations will be followed as per the orders of the Government of Tamil Nadu in vogue at the time of admission.

Tamil Nadu Ordinance No. 4 of 2007 published in the Tamil Nadu Government Gazette extraordinary No. 262 dt. 15.09.2007 provides for reservation in respect of annual permitted strength in each branch or faculty for admission into educational institutions in the State including private educational institutions. For the Backward Class Muslims it shall be three and a half percent within the thirty percent reservation for Backward Class as provided in the 1994 Act and in 2006 Act.

\*\* G.O. Ms. No. 50, Adi Dravidar and Tribal Welfare (TD-2) 29.04.2009. (16% seat offered to Arunthathiyars within the seats reserved for scheduled castes for admission in Educational Institutions).

- (a) Tamil Nadu native candidates alone will be considered for communal reservation. The community recorded in the certificate of Tamil Nadu native candidate should appear in the list of communities approved by the Government of Tamil Nadu. (Appendix-I)
- (b) The applicants from Tamil Nadu State should have obtained permanent community certificate in permanent card format/ electronic form/ digitally signed e-Certificate only from the competent authorities (Table 10) on or before the last date prescribed for submission of online application. Community Certificate obtained after the last date prescribed for submission of online applications will not be considered. Interim Court direction/interim orders unless final orders are issued will not be considered for providing communal reservation.
- (c) Community Certificate obtained from other states will not be considered for communal reservation.
- (d) For communities linked with Districts, the candidates should obtain their community certificate in the respective district except the communities mentioned in G.O. (ST) No. 95 BC, MBC & Minorities Welfare Department dt: 28.10.2009. Such of those Community certificates obtained on or after 28.10.2009 will be considered. Community certificates obtained from other than the respective district will not be considered.
- (e) Candidates who have not produced the Community Certificate in the form of Permanent Community [Card] Certificate or electronic form / digitally signed e- Certificate at the time of original certificates verification, their application will be treated under “Open Competition (OC)”. The candidate is further informed that in the event of such a decision, the eligibility conditions & rules prescribed for OC will be applicable for such candidates, and if such candidates do not satisfy the rules of OC, their applications are liable to be rejected. No correspondence in this connection will be entertained.

### 2.2.2 Special Reservations

A certain number of seats is also reserved for the following categories, as prescribed by the Government of Tamil Nadu G.O. Ms. No. 167 dt. 25.4.2008. A separate certificate with the necessary details issued by the competent authority concerned must be uploaded during the online application process and compulsorily produced at the time of certificate verification. A special processing fee of Rs.100/special reservation (except 7.5% quota) is to be paid along with the online application fee.

**Campus transfer is not permissible for candidates admitted under a special reservation quota under any account/circumstances.**

Since the special reservation applications require processing by separate committees, candidates are instructed to produce a Signed Application Form (generated on submission of online application) along with necessary original documents and appendices concerned to the Dean (Agriculture) and Chairman (Admissions), Tamil Nadu Agricultural University, Coimbatore on a stipulated date, which will be intimated to the candidate through the registered email id and mobile number. If the originals of the scanned certificates or supporting documents already uploaded are not produced for verification, their claim under such categories will not be considered. The scheduled date of certificate verification will be updated on the website and will be intimated to the candidate through their registered email and mobile number. The candidates who applied for these special reservations shall also be considered for general counselling in case of their non-selection or if the candidate is not willing to join. In such a case, the candidate must submit a request letter to this effect along with the parent's/guardian's signature.

### 2.2.3 Differently Abled

Five percent of the seats are reserved for differently abled candidates in the UG degree programs offered at the constituent colleges. Candidates seeking admission against this reservation set apart for Hearing impaired / Orthopedically Differently Abled / Visually Impaired should produce the certificate from the Medical Board of the District concerned certifying the nature and extent of disability in percentage.

Certificates obtained from an individual Doctor will not be considered. Further, a separate TNAU Medical Team will examine the candidates with reference to their certificates and his/her suitability for admission to TNAU.

This condition shall be verified by a medical team at the time of application scrutiny. Applicants should fulfill all the other qualifying requirements. However, the maximum age limit is relaxed to 26 years (as of 1<sup>st</sup> July 2026).

Candidates must produce a Signed Application Form along with necessary appendix [Appendix-III-A, Appendix-III-B, Appendix-III-C & Appendix-III-D], generated online application and Medical Certificate on a stipulated date and time.

### 2.2.4 Ex-servicemen

One seat for each of the degree programs in all constituent colleges is reserved for sons and daughters of Ex-servicemen. **This quota is not available for self-supporting courses.** The applicants should possess all qualifying requirements and should upload the proof of evidence issued by the competent authority. Candidates must produce both the Appendix-IV-A, Appendix-IV-B, Discharge Certificate, and Ex-serviceman ID cards of their parents for verification. Candidates claiming admission against the reservation of seats under this category should produce the certificate of dependency on Ex-servicemen in the prescribed format appended in the website [www.esmwel.tn.gov.in](http://www.esmwel.tn.gov.in)

### 2.2.5 Eminent Sportsperson

One seat for each of the degree programs in all constituent colleges is reserved for eminent sportspersons. **This quota is not available for self-supporting courses.** The applicants should fulfill all qualifying requirements and produce proof of evidence and copies of the certificate issued by the Sports Development Authority of Tamil Nadu.

Certificates obtained at the International / National / State level will be considered in the order of merit. The purpose of this quota is to recognize the sports eminence of the candidates, and hence marks for sports achievements alone will be considered for ranking the candidates. The candidates are expected to continue good performance in sports after their admission to Tamil Nadu Agricultural University. Candidates seeking admission against the special reservation of seats under eminent sportsperson should produce Appendix-V.

The highest achievement in a year for each of the last four years will alone be considered. A candidate can list a maximum of FOUR highest achievements. Preference for submission of certificates fully rests with the candidate. Selection of the candidate will be based on the sports marks obtained by following the guidelines given in Appendix-V. In case of a tie in the sports marks, the aggregate mark of the candidate (as described in Section 2.1.2) followed by date of birth (elder first) will be considered for ranking.

### **2.2.6 State Government School Quota**

Seven and a half percent (7.5%) of seats on a “preferential basis” are reserved for students from State government schools in admission to all undergraduate courses both in constituent and affiliated colleges of Tamil Nadu Agricultural University. These students (academic and vocational stream) should have continuously studied all classes from Class 6 to 12 in the State Government Schools of Tamil Nadu. Candidates who seek admission under this quota should furnish his/her EMIS number at the time of filling out the online application. The eligibility for admission under this quota will be verified by the Government of Tamil Nadu based on the EMIS number. Admission will be awarded only to the Government of Tamil Nadu-approved eligible applicants. TNAU will not hold any responsibility for the mistakes made in the EMIS provided by the candidates at the time of application filling. The candidates who do not have an EMIS number should obtain and upload a bona fide certificate in the prescribed format provided in Appendix-VIII.

### **2.2.7 INDIAN COUNCIL OF AGRICULTURAL RESEARCH (ICAR) QUOTA – (Supernumerary)**

Twenty percent of the sanctioned seats are allotted to the Indian Council of Agricultural Research, New Delhi, for filling candidates through the National Level Entrance Examination for programs viz., B.Sc. (Hons.) Agriculture (English medium) at Coimbatore, Madurai, Tiruchirappalli, Killikulam, Eachangkottai, Kudumiyamalai and Vazhavachanur (except Karur, Keezhvelur, and Chettinad), B.Sc. (Hons.) Horticulture (English medium) at Coimbatore, Periyakulam and Tiruchirappalli (except Paiyur), B.Sc. (Hons.) Forestry and B.Sc. (Hons.) Sericulture at FC&RI, Mettupalayam, B.Sc. (Hons.) Food Nutrition and Dietetics at CSC &RI, Madurai, B.Sc. (Hons.) Agribusiness Management at AC & RI, Coimbatore, B.Tech. (Biotechnology) at AC & RI, Coimbatore, B.Tech. (Food Technology) at AEC & RI, Coimbatore and B.Tech. (Agricultural Engineering) at AEC & RI, Kumulur. The responsibility for the processes of admission and filling of vacancies lies with ICAR, and TNAU does not bear any responsibility in this matter.

### **2.2.8 INDUSTRY SPONSORSHIP QUOTA (ISQ) AND NON-RESIDENT INDIAN (NRI) QUOTA – (Supernumerary)**

Candidates satisfying minimum mark requirements and maximum age limit can apply for either NRI or Industry Sponsorship quota. A candidate cannot apply for both NRI and Industry Sponsorship Quotas. The distribution of seats for each degree program under the Industry Sponsorship Quota (ISQ) and Non-Resident Indian (NRI) Quota is given in Table 2. There will be separate counselling for these quotas, and seats are allotted on a mark merit basis among the applicants under these categories and not on the communal reservations.

The candidates should have minimum educational qualifications as prescribed in Section 2.1.5. The upper age limit as prescribed for general counselling is applicable.

The candidates are requested to upload scanned copies of the necessary documents and appendices during the online application process. The originals should be produced at the time of verification, which will be intimated through the registered SMS and email.

### **Industry Sponsorship Quota (Supernumerary)**

A member of the Agribusiness Consortium of TNAU can nominate only one candidate for admission to the Undergraduate Program. Candidates of Indian Nationality alone are eligible to apply.

Any public/private limited industry directly related to agricultural manufacturing / production-related activities can sponsor one candidate once in four years by becoming a member of the Agri-Business Consortium (ABC) of Tamil Nadu Agricultural University, Coimbatore.

The company willing to sponsor the candidate must be registered under the Companies Act and produce the following documents (Appendix-X-A):

1. A letter expressing willingness to become a member of ABC addressed to The Secretary (Agri-Business Consortium) and Chairman (Admission), Tamil Nadu Agricultural University, Coimbatore-3. (Appendix-X-D)
2. Photocopy of Sales Tax Registration Certificate (GST)
3. Authorized signatory attested photocopy of PAN card along with Director Identification number of the sponsoring Company.
4. Self-attested photocopy of PAN card and Director Identification Number of the authorized signatory.
5. The company auditor attested photocopy of Audited Balance Sheet for the last three years (Financial year 2025-26, 2024-25 and 2023-24). (Proof for company auditor is to be attached).
6. A photocopy of the income tax return statement for the last three years attested by the company auditor / Authorized signatory. (Financial year 2025-26, 2024-25 and 2023-24). If accounts have not been completed for the financial year 2025-26, proof of advance tax paid for 2025-26 and a letter from the company auditor stating the status of accounting for the financial year 2025-26 should be submitted. In case of a change of company auditor, the respective GBM copy resolution and acceptance letter from the new auditor must be produced.
7. In case of an exception for tax payment, a copy of evidence shall be produced.
8. Photocopy of Certificate of Incorporation.
9. Photocopy of Article of Association and Memorandum of Association. (Proof for Authorized Signatory/Change of Director, if any, is to be produced wherever necessary) and
10. Sponsorship letter (Appendix-X-C)

Scanned copies of the originals must be uploaded at the time of the online application process. The originals must be produced at the time of verification, which will be intimated later through a registered mobile/ email.

A committee formed by the University will visit the sponsoring industry for verifying its genuineness and the expenditure incurred towards the visit of the committee (**Rs. 25,000/-** in the form of a Demand Draft drawn in favour of **“The Dean (Agriculture), Tamil Nadu Agricultural University, Coimbatore”**, payable at Coimbatore) must be borne by the sponsoring industry. This sum must be paid at the time of submitting the documents as a bound copy.

At the time of admission, the industry should enter an MoU (Appendix-X-B) with TNAU by signing an agreement in Rs.100/- non-judicial stamp paper and remit a **non-refundable ABC membership fee of Rs. 12.00 lakhs (rupees twelve lakhs only)** in the form of a single Demand Draft drawn in favour of **“The Dean (Agriculture), Tamil Nadu Agricultural University, Coimbatore”**, payable at Coimbatore. **The DD shall be taken after the date of provisional selection.** MoU Signing will be done only after the course selection in counselling and verification of necessary documents. **MoU should be signed IN PERSON by**

**the managing director of the industry.** Upon admission, the candidate has to pay the semester fee as per the course.

### ***Non-Resident Indian (NRI) Quota (Supernumerary)***

The candidate can be a Non-Resident Indian or ward of an NRI or close direct relative of a Non-Resident Indian (NRI). The semester fee for students joining under the NRI Quota is US Dollar (\$) 3300 per semester.

The following documents should be furnished for seeking admission under NRI quota (Appendix-XI-A)

1. A letter sponsoring\* the candidate for admission to the UG program (Appendix-XI-B)
2. Attested copy of Passport with Visa details of the sponsor
3. Proof for NRI to be obtained from the Indian Embassy of the respective country Note: Resident card / Green card / Permanent Resident card / Residence proof / Employment certificate/ OCI are not accepted as proof of NRI.
4. Proof of Relationship to the Candidate issued in the form of a Notarized affidavit (Appendix-XI-C). The Notary should give the particulars of entry made in the register maintained by him.

\* If the sponsor returns to India before the completion of the Academic Period (four years), he/she must remit the entire balance amount in one lump sum.

If any applicant, after securing an admission under Industrial Sponsorship Quota or NRI, is not eligible for a refund of **Rs. 12 Lakhs or US Dollar (\$) 3300** in case of his/her discontinuation or switching over to ICAR quota seat or any other institutions within the University or outside, at a later stage.

### **2.2.9 Study in India (Supernumerary)**

A fixed number of seats is allotted for foreign students who seek admission through ICCR (Indian Council for Cultural Relations) as approved by the 139<sup>th</sup> Academic Council.

### **2.2.10 Reservation for the students of Jammu and Kashmir and Ladakh (Supernumerary)**

A fixed number of seats is allotted in the courses viz., B.Sc. (Hons.) Agriculture and B. Tech (Agricultural Engineering) (Kumalur) are reserved for the students of Jammu and Kashmir, and Ladakh. The students for this quota will be admitted by the Government of India.

### **2.2.11 Transgender (Supernumerary)**

One seat for each of the degree programs in all constituent colleges is reserved for transgender. **This quota is not available for self-supporting courses.** The applicants should possess all prescribed qualifying requirements and should upload the proof of evidence issued by the competent authority.

## **3 MODE OF SELECTION**

The candidates must fill out their choice of degree program and college at the time of online application filling and online counselling (if required), based on which admission will be allotted.

### 3.1 ONLINE COUNSELLING

The selection process for general reservations for all undergraduate degree programs is done only through online counselling (single window system). The guidelines issued in the Government order G.O. (Ms). No. 191, of the Agriculture – Farmers Welfare (A.U.) Department, dated. 14.07.2025 will be adopted.

After the publication of rank lists, the eligible applicants will be notified through their registered E-mail and mobile number to participate in the online counselling. The ratio of candidates shortlisted for participating in the online counselling will be decided by TNAU based on the number of applicants. **CALLING FOR ONLINE COUNSELLING DOES NOT GUARANTEE A SEAT.**

- Shortlisted candidates must pay a non-refundable counselling fee of Rs. 3000/- (Rs.1500/- for SC / SCA / ST categories) through their login credentials (<http://tnau.ucanapply.com>). Those who fail to pay the counselling fee will not be considered for online counselling.
- During online counselling, the applicants can change their Degree and College, choice preferences made by them at the time of application filling, as per the procedure given in section 2.1.1.
- During the online counselling, the finally submitted course and college choices of applicants will alone be considered for further processing. An SMS and e-mail will be sent to the candidates in this regard. If no modification is done by an applicant during the online counselling in College and Degree program choices, the preferences exercised by him/her while applying the online application will be considered for seat allotment.
- Subsequent options will not be given to the applicants to modify their college/course options in subsequent counselling/ upward movement sessions.
- On the expiry of the online counselling date of the respective phase, the degree and college allotment will be done based on the applicant's final course/college choice, merit, and communal reservation. The allotment will be informed to the candidates through SMS and email. The detailed instructions on admission fee payment, downloading of the allotment letter, and documents required for verification and submission will be sent through a registered email.
- The following options will be given to the applicants after securing a seat after online counselling and seat allotment.

\* The applicants who expressed willingness to accept and upward movement option will be

notified about their new course and college options, arises if any, at all upward movements. The applicants must choose their options within the stipulated time, otherwise, they will be moved upward if vacancy is available, as per their filled order of preference till the completion of the counselling. Claims at a later date will not be considered.

- The candidates who registered (Counselling fee paid) for online counselling and did not get any seat allotment in the first round of counselling will be considered for allotting a seat during the subsequent upward movement process if a vacancy arises.
- The applicants who secured a seat will be called for certificate verification and submission on a stipulated date specified by the Chairman (Admissions) to confirm their seats allotted to them.
- Before appearing for certificate verification at TNAU, Coimbatore, the candidates are required to pay an amount of Rs. 20,000/- towards the admission fee by online mode. Only on successful payment of the admission fee, the allotment letter can be downloaded. This amount will be adjusted in their first-semester fee. ***Paying the admission fee does not guarantee the confirmation of a seat. Confirmation will be done only after the verification of certificates/documents and their submission before the stipulated time.*** A provisional admission card will be issued after successful verification. However, if the admitted candidates require their certificates for verification for any other official reasons, they can collect the certificates after submitting a request letter with a valid proof. The certificates shall be returned to the University after the verification within the stipulated time.
- On the day of certificate verification, if any credential of the applicant (Marks and qualification, Community, Date of Birth, Nativity, etc.) is found incorrect, the allotment for that counselling round will be cancelled. If the candidate is willing to secure admission further, he/she will be called for a re-counselling based on his/her revised credentials and there is no assurance of any seat at that point of time.
- On the day of certificate verification, the applicants and their parents will be explained about the upward movement (sliding). The applicants can choose either willing or not willing for the upward movement option. The choice is purely rest with the applicant. Once the choice is made it cannot be changed. A request for willing or not willing cannot be entertained at a later date.
- **The admission fee (Rs.20,000/-) is REFUNDABLE if the candidate has not registered in the first semester of the degree program, and it is non-refundable if (i) a candidate withdraws his/her already secured admission under the government quota and is willing to get an admission under the management quota in an affiliated college and (ii) an applicant discontinue course after registration of first semester.**
- Delay or absence for submission of certificates/documents and payment of fee will result in the cancellation of the secured seat.
- Separate IN-PERSON counselling will be conducted at TNAU Coimbatore for special reservations (Differently abled, Eminent Sportsperson, Ex-servicemen, NRI, and Industrial Sponsorship quotas) and general counselling based on necessity.
- Candidates of Tamil Nadu nativity who have applied for any one of the special reservations are also eligible for general counselling.

### 3.1.1 Upward movement system

- In case a vacancy arises, candidates who expressed willingness for the upward movement at the time of certificate verification will be considered for a movement to their best preferred upward choice of Degree and College based on merit and communal reservation.
- An upward movement system will be followed for all online counselling based on vacancy.

### 3.2 OFFLINE COUNSELLING

Offline counselling will be conducted for Special reservations (Differently abled, Eminent Sportspersons, and Ex-servicemen). Offline counselling for differently abled, eminent sportspersons and ex-servicemen quotas will be conducted ahead of general counselling. Offline/online counselling for NRI and Industrial Quota will be conducted after one or two phases of general counselling.

Candidates attending special reservation counselling must bring the necessary original document/certificate pertaining to their special reservation. If valid/original documents are not produced by the candidates during the counselling, they will not be allowed to attend the counselling process.

TNAU can also conduct offline counselling(s) for the general and other quotas if required.

#### 3.2.1 Offline Counselling Process

Candidates can choose the Degree and College based on their rank during OFFLINE counselling. Attendance of candidates will be marked both at the entry and exit. Candidates have to appear at the venue and exercise their option when called according to rank order, the highest rank holder of the available candidates will be called first and so on. Candidates have to opt for a degree and college which is available at the time of counselling. **DEGREE AND COLLEGE CHOICE ONCE MADE IS FINAL AND CANNOT BE CHANGED.** Generally, the upward movement system will not be adopted in the offline counselling(s). In case of requirement for such adoption, the fresh course options will be obtained from the applicants as deemed fit. The decision of the Dean (Agriculture) cum Chairman (Admissions) will be the final in this matter. Candidates who have attended counselling and did not select any choice will not be considered for future counselling phases in the academic year. **CALLING FOR COUNSELLING DOES NOT GUARANTEE A SEAT.** TA and DA will not be given for attending counselling.

The following options exist for the candidate at the time of offline counselling:

Note: THERE IS NO WAIT LIST OPTION IN THE COUNSELLING PROCESS

Candidates who fail to attend the counselling on the specified date and time will forfeit their right to admission. However, due to unforeseen and unavoidable reasons, if a candidate is unable to attend the counselling on the specified date and time, the candidate can authorize their parent/guardian on their behalf, and the parent's /guardian's decision will be binding and final. Such authorization letter should bear photographs of the candidate and authorized person (candidate's parent/guardian) and be signed by both the candidate and authorized person. The authorized person attending the counselling on behalf of the candidate should carry the counselling letter and a photocopy of the ID proof. On demand, the authorized person must produce the ID proof in its original form for verification. The format for the authorization letter is provided in Appendix-XII.

### 3.3 Supplementary application and admissions

As per the guidelines issued in the G.O.(D). No. 24 of Agriculture – Farmers’ Welfare (AU) Dept. dated 31.01.2025, the supplementary online application portal will be opened for 2-3 days after the declaration of supplementary exam results by the Tamil Nadu Higher Secondary Board. The candidates who missed applying earlier to TNAU and passed afresh through the supplementary examination can apply. The residual seat matrix arrived after the general counselling will be utilized for the supplementary counselling. The merits and qualifications prescribed for the general counselling and admissions steps adopted in the general counselling are applicable to this admission as well. The rights to decide to provide the supplementary application option and its duration, need-based modifications to the admission steps, and the various time stipulations for these admission steps are reserved with Tamil Nadu Agricultural University and its Chairman of Admissions.

### 3.4 Spot Admission

As per the guidelines issued in the G.O.(D). No. 309 of Agriculture – Farmers’ Welfare (AU) Dept. dated 27.09.2024, spot Admission will be conducted for the vacant seats of affiliated colleges after the opening of the colleges. Spot admission is an offline counselling process. Spot admission applies only to affiliated colleges. The vacancies in the constituent colleges will be kept vacant. No upward movement process will be followed. For spot admission, counselling fee will be collected only from the candidates who availed a seat. After selection, the candidate must pay the counselling fee as prescribed above.

The vacancy position, college-wise and community-wise will be published on the TNAU website on the day of spot admissions and if required a press release shall be given for a larger reach. Candidates will be called in a ratio of 1: 10 or more depending on the situation. Applied candidates who have not attended the counselling earlier or those who have not got a seat in the general counselling or already secured admission under the management quota can attend the counselling. Applicants who already secured admission but cancelled their seats or discontinued or secured an admission are not eligible. TA and DA will not be given for attending counselling. Attendance will be marked, and a ranking of attendees will be done. Candidates will be called based on their rank for choosing the college and seat. The Government orders/guidelines issued for the communal reallocation may be adopted as deemed necessary after the expiry of the applicants in a particular category.

Selected candidates must join the college immediately by submitting the educational certificates and by paying an admission fee of Rs. 20,000 which will be facilitated on the university campus itself on the day of spot admission. Calling for Spot Admission does not necessarily GUARANTEE a seat.

The affiliated colleges can fill the vacancies after spot admissions (lapsed seats) as per the guidelines issued in the Government Order G.O. (D). No.309 Agriculture and Farmers’ Welfare (AU) Department dated 27.09.2024.

No candidate will be admitted after the announcement of “Completion of Admission” for the academic year.

### 3.5 Filling of Non-Surrendered Management Seat

The affiliated colleges can admit only the applicants who have applied to TNAU to fill their non-surrendered management quota seats.

## 4 SYSTEM OF EDUCATION

The medium of instruction is English in all colleges except for the Tamil medium students of AC&RI, Coimbatore, and HC&RI, Coimbatore, and the evaluation pattern in the University is “Semester Course Credit System”. All Undergraduate Programs are eight Semesters (4 years) in duration. An enrolled student to earn a bachelor’s degree should complete the course credits prescribed from time to time and should have earned a minimum Overall Grade Point Average (OGPA) of 6.50 out of 10.00.

The e-learning initiatives in TNAU necessitate the use of laptops for learning as well as for assignments. Admitted candidates may preferably have a laptop throughout their courses of study.

## 5 RAGGING

Ragging in any form, place, or time is a cognizable offense that will attract severe punishment, including summary expulsion from the institution. (Tamil Nadu Government Gazette Extraordinary dt.29.01.97, Bill No. 8 of 1997, Tamil Nadu Publication of Ragging Act.). Hence, TNAU shall make all institutional arrangements to check ragging in all constituent and affiliated campuses.

## 6 FEE AND DEPOSITS

Each admitted candidate is required to pay fee according to the institute and degree program to which they are selected.

The admission fee of Rs. 20,000/- collected during the time of seat allotment will be adjusted with the Semester fee. The difference of amount has to be paid by the candidate before registration at the time of the college opening at the respective institutes.

### 6.1 Fee Structure for Constituent Colleges of TNAU (As per Table 11)

#### A1. Science Programs

The following eight undergraduate degree programs, namely, B.Sc. (Hons.) Agriculture (English medium), B.Sc. (Hons.) Agriculture (Tamil medium), B.Sc. (Hons.) Horticulture (English medium), B.Sc. (Hons.) Horticulture (Tamil medium), B.Sc. (Hons.) Forestry, B.Sc. (Hons.) Sericulture, B.Sc. (Hons.) Food, Nutrition & Dietetics and B.Tech. (Agricultural Engineering) at AEC&RI, Kumulur are treated as agricultural science programs for the purpose of fee.

#### A2. Technology Programs

The following seven undergraduate degree programs namely, B.Tech. (Food Technology), B.Tech. (Biotechnology), B.Tech. (Bioinformatics), B.Tech. (Agricultural Information Technology), B.Sc. (Hons.) Agri Business Management, B.Tech. (Energy and Environmental Engineering), and B.Tech. (Agricultural Engineering) at AEC&RI, Coimbatore, are treated as Agricultural Technology programs for the purpose of fee.

## **6.2 Fee for Affiliated Management Colleges**

Candidates admitted through counselling and management quota in the Affiliated colleges have to pay an all-inclusive, annual tuition Fee of Rs. 50,000/- as fixed by the Government of Tamil Nadu (G.O. (Ms.) 233 of Agriculture (AU) department dated 8.10.2020) except College of Agricultural Technology, Theni, TRIARD, Perambalur, and KRISAT, Usilampatti. In these three colleges, the students admitted in the Government quota have to pay the annual fee of Rs. 40,000/- and the management quota admitted students have to pay an annual fee of Rs. 70,000/-.

## **6.3 Refund of Semester Fee**

Students discontinuing the program before registration for the first semester are eligible to get a full refund of the semester fee. Those who discontinue the course after registration for the first semester are eligible to get a refund of only the caution money deposit from their respective campuses.

The admitted candidates in the constituent colleges must pay an additional one-time sports development fee of Rs. 750/- after registering in the first semester.

## 7 SCHOLARSHIPS

Fee concessions and scholarships such as Adi Dravidar welfare scholarships, Central Government scholarships, State Government free education for students from non-graduate families, Periyar Endowment scholarships and fellowships and scholarships from the Indian Council of Agricultural Research, New Delhi and other agencies are available for the benefit of deserving enrolled candidates. These may vary according to the degree/college to which candidates are admitted and the respective funding agencies.

## 8 FACILITIES AND RESTRICTIONS

- TNAU, with a view to improve the overall student personality, integrates certain compulsory courses like Yoga, NSS/NCC, Physical education etc., in its regular syllabi. Further, an exclusive officer at the University level (Dean, Students' Welfare) is functioning to coordinate the student placement and higher education activities.
- Campus transfer is not permissible.
- Separate hostels for men and women are available in each campus with Wi-Fi Internet connectivity. Specified uniforms are mandatory for classes/field/lab work.
- Students run messes on a dividing system basis.
- All students are expected to reside in the hostel attached to the respective colleges. In exceptional cases, the Dean is empowered to permit students to be day-scholars.
- A Students' Centre with a canteen is available in each campus to provide stationery and essential items.
- Infrastructure facilities exist in all colleges for extracurricular activities.
- Library and sports facilities are available in all campuses.
- Students are not allowed to own and drive motorcycles/cars in campus, failing which the students will not be given hostel accommodation. Parking vehicles elsewhere on the campus and usage is also equally punishable. An undertaking in this regard is enclosed in the proforma XIII, in which both the parent and student have to sign.
- Mobile phones are banned in the classroom.

## 9 REPORTING TO ADMITTED COLLEGES

Newly admitted students should report to the allotted college in the scheduled time as given in the admission letter/ as per upward movement, failing which their admission will be cancelled. No exemption or permission will be entertained in this regard.

## 10 DISPUTE REDRESSAL

With regard to the interpretation of the provisions of any matter not covered in this information brochure, the decision of the University will be final and binding on all the parties concerned. Any complaints, grievances, etc., related to UG admissions and academic matters must be first referred to the Chairman (Admissions) and Dean (Agriculture), Agricultural College and Research Institute, Coimbatore who will be the appellate authority to redress such complaints /disputes. The Courts having their jurisdiction at Coimbatore alone can adjudicate on all matters and disputes related to admissions and academic matters (Candidates applied for TNAU/TNAU & TNJFU and admitted in TNAU). Further, any legal question arising out of the admission shall be entertained only when raised within 30 days from the declaration of the result. No Disputes will be entertained after the closure of admission.

The Private colleges/institutes affiliated to TNAU are not authorized to admit any candidate against the seats allotted under the government quota of 65% or 50% as the case may be without specific prior approval of the Government of Tamil Nadu and TNAU. TNAU is not liable and legally binding for any admissions made under the lapsed seats violating the rules and regulations prescribed by the Government of Tamil Nadu/TNAU for the admission of the candidates under government quota seats. The candidate admitted without the University approval and violating the above rule, will not be treated as students of TNAU and cannot claim any right from TNAU.

TNAU will not be responsible for the return of the certificates, or any fee remitted by the candidates admitted under the Management Quota by the private colleges/institutes affiliated to TNAU. Nothing is binding for TNAU for any of the legal issues raised by the students admitted under Management quota against the management, related to issues of certificates, fee remitted etc.

## 12 OTHER GUIDELINES

### 12.1 Use of Vehicles inside College Campus

Use of motorized two/four-wheeler is not permitted for the hostellers. Day scholars ought to park their motorized two/four-wheeler at the parking lot specified by the Security Officer or respective college administration. The day scholars should use only their bicycles for inside campus movement. An undertaking for not using motorized two/four-wheeler vehicle inside the campus has to be submitted by the student after joining the college (Appendix-XIII).

### 12.2 Guidelines for ICAR quota

In the case of a student who was originally admitted under the single window system of counselling, later if he/she has secured admission under ICAR quota and is willing to shift the college/course, he/she is permitted to do as per the rules and regulations of TNAU. However, the ABC membership fee and NRI quota fee paid for the industrial sponsorship/NRI quota is non-refundable.

2. Marks will not be awarded for selection trials and coaching camps.

1. Tamil Nadu Board schools, KVS / ICSE/ISC and CBSE Schools, School Zonal and School cluster level achievements will not be considered.
2. The candidates participated in the tournament conducted by CBSE, ICSE/ISC and KV Schools, at Regional / South Zone are equated to Regional Level Achievements, and the National Level Achievements are equated to State Level of State/ Matric Board Schools.

#### 5. General Conditions

1. For consideration of candidates seeking admission under the category of eminent sports person, he/she should enclose all the attested photo copies of participation certificates and the relevant forms issued by the competent sports authorities. **The application along with all the sports certificates/ relevant forms/ documents as given in 4(a), should be presented for certificate verification which will be done at Tamil Nadu Agricultural University, Coimbatore – 641 003.**

National or State Level Championships or Tournaments conducted by Sports Federations or Associations recognized by MYAS or IOA or SDAT or TNOA alone will be considered for the award of marks. (Recognition of State Associations / National Federations should be relevant to the year concerned).
3. Relevant attested copies of certificates issued by the competent authorities as detailed below are to be submitted along with the application before the last date for receiving the applications.
4. **Invitational or Memorial or any indifferent nomenclature or title of tournaments or Private Nonaffiliated or Championships at District or State or National or International level will not be considered for marks.**

5. District or Inter-District Championship means the championships conducted by the respective recognized District or State Sports Association for the State of Tamil Nadu.
6. Direct participation or achievement at any level without participating in the qualifying level competitions such as District or State or National or direct selection conducted by District or State Sports Association or National Sports Federation to represent the District or State or National or International tournaments or championships will not be considered for award of marks.

For International achievements in Tennis, marks for Gold, Silver and Bronze will be awarded to players who are ranked first, second and third respectively in the ATP or WTA rankings of International Tennis Federation for awarding participation marks for the top 5 ranked players will be considered from the ATP or WTA list published by the International Tennis Federation. 16. A Common Committee for Agricultural UG Programs constituted for this purpose will rank the candidates based on the marks assigned to the certificates enclosed along with the application. Candidates with a minimum sports mark of 5 and above alone will be considered for ranking.

**17. All the achievement certificates are to be supported necessarily by the relevant participation certificates and appropriate forms.**

18. Highest achievement or participation certificates obtained by candidates at different levels such as District or State or National or International in each year along with earlier achievements should be enclosed without fail. 19. Candidates in proportion to the available seats will be called to appear before the Common Committee for Agricultural UG Programs for verification of the Originals, followed by counselling after ranking.

WHEREAS the TNAU in the first part accepts the proposal of the COMPANY in the SECOND PART to become a member of ABC constituted for the purpose of effective linkages mutually agree for the objectives and terms and conditions laid herein under in real spirit and benefit of both parties towards development and strengthening of such linkages.

**OBJECTIVES:**

- a. To encourage deeper commitment and involvement of industries in supporting development of new programs and courses for which there are sufficient demand in Agriculture and allied industries.

- b. To facilitate agriculture and allied industries to interact with the concerned Department of the University in restructuring the curriculum taking into account the field of immediate and long-term relevance to the industries.
- c. To mobilize assistance from Agriculture and allied industries for training and placement of students.
- d. To organize jointly with Agriculture and allied industries, thematic seminars and conferences which have mutual benefit to the agriculture and allied industries and the University.
- e. To attract more collaboration to support significant research programs of vital interests to Agriculture and allied industries.
- f. To promote technical personnel interchange by creating provision for faculty to work in agriculture and allied industries for short duration and by encouraging competent professionals from the agriculture and allied industries to take up teaching/research activities in the University for short duration through Visiting Faculty or Adjunct Professor appointments.
- g. To admit suitable candidates sponsored by Agriculture and allied industries to the under graduate degree program against the reserved seats and to throw open industry related laboratory facilities available at the University to these candidates who would be committed to return to the sponsoring industry after graduation.

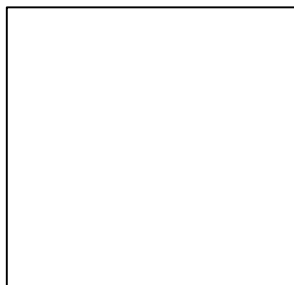
