The candidates who have been admitted provisionally to the Main Examination are directed **to pay ₹ 150/-**-(Rupees One Hundred and Fifty only) towards the examination fee (unless exemption of fee is claimed in the online application), through their registered One Time Registration ID from **23.12.2025 00.00 Hrs to 29.12.2025 11.59 PM.**

The candidates **who have claimed exemption from appearing for 'Tamil Eligibility Test' in the online application, are directed to upload the certificate** in the form prescribed in para 2.4. of Annexure-II of the Notification for the said recruitment, through their registered OTR ID, from **23.12.2025 00.00 Hrs to 29.12.2025 11.59 PM.**

The provisional admission to the said Main Examination is based on the claims (viz., Age, Communal Category, Gender, Religion, Educational Qualification, Technical Qualification, Physical Standards, Differently Abled Category, PSTM, Post option for Forester, etc.) made by the candidates in the online application for the said recruitment.

The candidates mentioned in List-I below are eligible for all the posts including the posts prescribing specific educational/technical qualification, provided they possess the prescribed qualification except For the post of Forester (Post Code:3362) in Forest Department (for the Vacancies Reserved for Outstanding Sportspersons) as per the notification for the said recruitment.

2. *The candidates whose register number is found in the above list have been admitted PROVISIONALLY to the Main Examination based on the marks obtained by them in the said Preliminary Examination and with reference to rule of reservation of appointments in the ratio of 1:10. However, with reference to para 5.5. and 5.6. of the said Notification, the candidates who have secured the same marks as that of the cut-off marks of their reservation group, have also been admitted provisionally to the Main Examination, though the number of candidates admitted to the Main Examination exceeded the 1:10 ratio.*

The admission of candidates to the said Main Examination is provisional subject to verification and acceptance of the claims as made in their online application with regard to Age, Communal Category, Gender, Religion, Educational Qualification, Technical Qualification, Physical Standards, Differently Abled Category, PSTM, Post option for Forester, etc., through requisite documents. Any discrepancy between the details as given in the online application and the documents submitted shall result in the rejection of candidature after due process.
4. *The candidates who have appeared for the said Preliminary Examination and whose register number is not found in the above list have not been admitted to the said Main Examination. Individual communication in this regard will not be sent to those candidates.*

The admission of the above candidates to the said Main Examination is purely provisional subject to the decision of the Hon'ble Commission and other cases relating to this recruitment, if any, under subjudice in the Hon'ble High Court of Judicature at Madras / Madurai Bench of Madras High Court.
